

# Donor & Sponsor Packet

## What we do

Global Impact Corps turns community-led ideas into completed, verified missions. Anyone can submit an idea. Approved missions are planned with professional support (Plan Lab), executed with local partners and local volunteers, and led end-to-end by a paid Project Steward (primarily young adults).

## Why it matters

Many young adults want to do meaningful work, but financial instability and lack of tools stop them. We remove that barrier by providing structure, planning support, safety controls, and capped compensation so participants can deliver real outcomes for real communities.

## How missions are funded

Donors can give unrestricted support or sponsor a specific, approved mission. Funds are released based on milestones with documentation and partner sign-off. Mission sponsorship is subject to Global Impact Corps retaining control and discretion over charitable funds and may be re-scoped or paused for safety/compliance reasons.

Tier	Typical gift	What it funds ()
Micro Mission Sponsor	\$5,000	Materials, local volunteer mobilization, closeout reporting
Mission Sponsor	\$25,000	A full small mission with a Project Steward + local partner support
Major Mission Sponsor	\$100,000	A larger mission with independent verification + deeper training
Founding Partner	\$250,000+	Multiple missions + Plan Lab capacity + rigorous reporting

## How sponsorship works

Each mission is published with a scope, budget, timeline, and verification plan. Sponsors receive milestone updates and a closeout report at completion.

## Verification & transparency

For every mission we document: (1) planned vs. actual budget, (2) milestone evidence (photos, receipts, attendance sheets, partner sign-off), and (3) post-handover ownership and maintenance plan. Higher-budget missions may require independent verification.

## Where your gift goes

Typical cost categories include:

- Direct mission costs (materials, equipment, contractors/trades where needed)
- Local volunteer mobilization (safety supplies, training materials, meals/water for work days)
- Project Steward and operations support (capped compensation, supervision, logistics)
- Verification and reporting (evidence management, independent review for major missions)

## Frequently asked questions

**Is my gift tax-deductible?** Contributions are intended to be tax-deductible to the extent permitted by law.

**Can I earmark funds to a specific person?** No. Gifts cannot be directed to pay a specific individual. Sponsors may support a mission, and Global Impact Corps retains control and discretion over charitable funds.

**How do you manage safety and risk?** Missions must meet security, safeguarding, and legal requirements and may be delayed or canceled if conditions change.

**Do you hire locally?** Yes. We prioritize local volunteers and local skilled trades wherever feasible.

## Mission timeline

Milestone	What happens	Evidence
M1: Plan complete	Scope, budget, partner MOU finalized	Mission plan, budget, MOU
M2: Procurement complete	Materials/vendor selection documented	Quotes, SOWs, receipts
M3: Build/implementation	Work completed to spec	Dated photos, logs, sign-in sheets
M4: Handover & training	Local ownership + maintenance	Training attendance, partner sign-off

Note: Timelines and milestone structures vary by mission size and context.
